Flagler County Supervisor of Elections, Kaiti Lenhart stated, "We continue to see an increase in Vote By Mail and Early Voting in Flagler County, which mirrors the same trend for voting methods statewide. I expect an overall turnout to be near 80% for Flagler County, especially with the voter registration and civic education program I have implemented for the 2016 election cycle."

The Secretary of State and Division of Elections Director were also pleased to hear the Elections Office would be working together with County Administration and the School Board for the voters of Flagler County to provide facilities for poll worker training classes and delivery of voting equipment, which have been outsourced over the past few years. "This consolidation and use of county resources will be a tax savings to the citizens of our county and works towards my goal of rebuilding a solid working relationship with the other government agencies in our county." said Kaiti Lenhart, Flagler County Supervisor of Elections.
