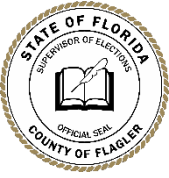

A recount is required for any municipal election race with a margin less than one-half percent. Vote-By-Mail and Election Day returns were fully reported at 7:27 P.M. and show a 0.72% margin in the City Commissioner Special Election, vote for one race.

One provisional ballot was cast at the polls on Election Day. A decision to accept or reject the ballot, based upon the voter's eligibility will be made by the City of Bunnell Canvassing Board on Friday, March 8 at 2:00 P.M. If that ballot is accepted and the margin of difference between Henry and Reeger is less than 0.5%, a machine recount will occur immediately at 3:00 P.M. on Friday, March 8, 2019.

Candidates, representatives, committees of the current election as well as the public are encouraged to attend and observe.

Persons are advised that if they decide to appeal decisions made at this recount they will need a record of the proceedings and for such purpose they need to ensure a verbatim record of the proceeding is made, which includes the testimony and evidence upon which the appeal is to be based.

Persons with disabilities requiring reasonable accommodations to participate should call the Supervisor of Elections Office at 386-313-4170, as soon as possible prior to the meeting.
